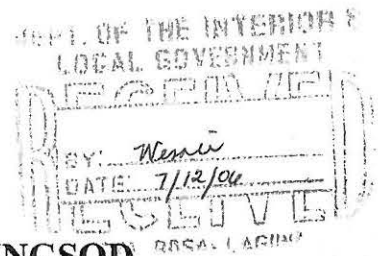

ORDINANCE NO. 1463-2006

(Motioned by the Committee on Laws and Government)

AN ORDINANCE ESTABLISHING THE BARANGAY DITA ROTONDA PARK AS THE CITY OF SANTA ROSA'S FREEDOM PARK OR PLAZA IN COMPLIANCE WITH THE SUPREME COURT'S EN BANC DECISION IN G.R. Nos. 193838, 169848 AND 169881 AND IN COMPLIANCE WITH THE MANDATE OF BATAS PAMBANSA BILANG 880, OTHERWISE KNOWN AS THE PUBLIC ASSEMBLY ACT OF 1985.

WHEREAS, Section 15 of Batas Pambansa Blg. 880, otherwise known as the Public Assembly Act of 1985 provides for the establishment or designation of Freedom Parks;

WHEREAS, in the Supreme Court En Banc Decision in G.R. Nos. 193838, 169848 and 169881, all cities and municipalities are hereby enjoined to designate freedom parks in all cities and municipalities in compliance with the provisions set forth by BP Blg. 880;

WHEREAS, DILG Memorandum Circular No. 2006-42, dated May 4, 2006 was issued to provide guidelines to ensure the establishment or designation of Freedom Parks in local government units through an ordinance in accordance with the above-mentioned law and Supreme Court Decisions.

RESOLVED, as it is hereby RESOLVED to establish Barangay Rotonda Park as the City of Santa Rosa's Freedom Park or Plaza in compliance with the Supreme Court's En Banc Decision and in compliance with the mandate of Batas Pambansa Blg. 880, otherwise known as the Public Assembly Act of 1985.


