ORDINANCE NO. 1554-2008

AN ORDINANCE GRANTING THE BENEFIT OF FREE MOVIE VIEWING TO PERSONS WITH DISABILITIES WHO ARE REGISTERED AND HOLDERS OF THE CITY OF SANTA ROSA PWD I.D. CARD PLUS, AT ALL MOVIE THEATRES IN CITY OF SANTA ROSA, SUBJECT TO ALL LAWS AND EXISTING LEGAL RULES AND REGULATIONS.

WHEREAS, the City of Santa Rosa has persons with disabilities (PWD) who are registered with and holders of the Santa Rosa PWD ID Card Plus issued by the City of Santa Rosa Social Welfare Office;

WHEREAS, persons with disabilities belong to the disadvantaged sector of our society who, because of their special physical and mental conditions have no means of and/or limited capacity to earn income for living, much less for entertainment diversions;

WHEREAS, the City Government is cognizant of the plight of persons with disabilities who, like the senior citizens of this city, deserve the care and compassion of the city in making their lives brighter and better amidst all their difficulties;

NOW, THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF SANTA ROSA, LAGUNA, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED THAT:

Section 1. The benefit of free movie to persons with disabilities, who are registered and holders of the City of Santa Rosa PWD ID Card Plus, at all movies and movie houses in the City of Santa Rosa, is hereby granted, subject to all laws and existing legal rules and regulations.

Section 2. The budget for the purpose shall be taken from the Annual Executive Budget under Special Activities Fund of the Office of the City Mayor.

Section 3. Let a copy of this Ordinance be furnished the City of Santa Rosa Social Welfare Office and other concerned offices for their information and guidance.

Section 4. This Ordinance shall take effect immediately upon its approval.
