**RESOLUTION NO. 117-2006**

(On motion by the Committee on Laws and Government)

A RESOLUTION REQUESTING THE CITY OF SANTA ROSA PHILIPPINE NATIONAL POLICE (PNP) TO LOOK INTO REPORTS THAT THE SECURITY PERSONNEL OF LA JOYA SUBDIVISION (LJS), AS EMPLOYED BY THE HOMEOWNER'S ASSOCIATION (HOA), ARE COERCING RESIDENTS NOT OF GOOD STANDING, GOING TO AND FROM THEIR PLACE OF RESIDENCE, TO LIFT THE 'BARRIER OR BOOM' SITUATED AT THE LJS ENTRANCE GATES.

**WHEREAS**, after a Committee Hearing was conducted by the Committee on Laws and Government on March 30, 2006 with respect to the issue involving an impending policy by the LJS HOA, requiring that only homeowners of good standing will be provided security stickers and residents who are not issued such will be required to log-in and leave their identification cards at the gate upon entry, a compromise agreement was reached by both parties;

**WHEREAS**, as agreed, security stickers shall be provided to LJS residents not in good standing allowing them free access to the subdivision gates to and from their residence;

**WHEREAS**, as agreed and understood by the Committee on Laws and Government, as to the real intention of the compromise agreement, free access means access without any form or any kind of restriction;

**WHEREAS**, there are persistent reports that the security personnel of LJS are coercing residents not of good standing going to and from their place of residence to lift the barrier or boom situated at the LJS entrance gates, clearly in violation of the compromise agreement;

**WHEREAS**, if such reports are true, not only is it inhuman and degrading, it is also clearly an infringement of one's constitutional right to freedom of movement especially in going to and from one's residence, having no place in civilized society;

**WHEREAS**, it is in the best interest of all concerned, including the City of Santa Rosa, that the matter be resolved immediately, if only to ensure the maintenance of Peace and Order among the residents of LJS;

**RESOLVED**, therefore, as it is hereby resolved that the SP adopt Resolution 117-2006.
