RESOLUTION NO. 118-2006

(On motion of SP Member De Guzman and seconded
by SP Member Cendaña)

A RESOLUTION REQUESTING THE CENRO TO STUDY AND IF NECESSARY TO RECOMMEND TO THE CITY LEGAL OFFICE THE FILING OF APPROPRIATE CHARGES TO THOSE POSTING PROTEST MATERIALS AT THE BULWAGAN OF THE SP IN VIOLATION OF ORDINANCE NO. 1366-2004.

WHEREAS, the walls of the Sangguniang Panlungsod (SP) Building has been posted by protest materials against Members of the SP every session date since the removal of Raymond Ryan Carvajal as City Sangguniang Kabataan (SK) Federation Vice-President and as an Ex-Officio Member of the SP;

WHEREAS, as evidenced by the pictures provided for in Annex "A" attached in this resolution, it was discovered that such protest materials are removed after each and every session and deposited to the Bulwagang Kapulungan of the SP for safekeeping, only to be re-posted again at the next session date;

WHEREAS, these acts are clearly in violation of City Ordinance No. 1366-2004, the Title and Penalties of which read as follows:

PANGKAT 3. PARUSA – Ang sinumang lalabag sa Kautusang ito ay lalapatan ng parusang pagmumulta ng hindi bababa sa Isang Libong Piso (P1,000) o pagkakakulong ng labin-limang araw at hindi tataas ng Limang Libong Piso (P5,000) o pagkakakulong ng isang (1) buwan o ang magkaparehang parusa sang-ayon sa kapasiyahan ng Hukuman.

WHEREAS, the SP is an independent institution that is expected to be accorded the respect it very well deserves, as its members are likewise expected to abide by the law which they themselves have legislated;

WHEREAS, Sec. 481, Paragraph (b) Number 3 (i) of R.A. 7160 or the Local Government Code of 1991 provides that:

Xxx The legal officer, the chief legal counsel of the local government units, shall take charge of the office for legal services and shall: Xxx In addition to the foregoing duties and functions, the legal officer shall: Represent the local government unit in all civil actions and special proceedings wherein the local government unit or any official thereof, in his official capacity is a party. Xxx

Premises considered, it is respectfully recommended that:

1. The City Legal Officer, after the City Environment and Natural Resources Office have made a recommendation, take immediate action on this matter, if only to ensure the integrity of the SP and Ordinance No. 1366-2004 which the former has legislated and which the City Mayor has the duty and responsibility to implement.
2. The City Legal Officer seek the maximum penalty to be meted out to those who have so blatantly violated Ordinance 1366-2005 in utter disrespect for the SP and its members.

THEREFORE, by virtue of a motion duly seconded, it is:

RESOLVED, therefore, as it is hereby resolved that the SP of the City of Santa Rosa adopt Resolution 118-2006.
