RESOLUTION NO. 125-2006

(Sponsored by the Committee on Laws and Government)

A RESOLUTION DESIGNATING LOTS 268-A1, 313, 314 and 322 OF THE CITY GOVERNMENT OF SANTA ROSA, SITUATED AT BARANGAY MARKET AREA, CITY OF SANTA ROSA AS SITE FOR THE DEVELOPMENT OF A GOVERNMENT CENTER COMPLEX.

WHEREAS, the Sangguniang Panlungsod (SP), having received a letter from the Local Chief Executive on April 18, 2006 with respect to the latter's proposed Government Center Complex to centralize all government related offices in one contiguous area for better efficiency and effectiveness in the delivery of frontline city government services, and after the matter has been referred by the Presiding Officer to the appropriate committees, a Joint Committee Hearing was conducted by the Committee on Laws and Government, and the Committee on Education on April 28, 2006;

WHEREAS, after a Joint Committee Hearing was conducted by the committee on Laws and Government and the Committee on Education, and in consideration of the urgency of the matter as certified by the Local Chief Executive, it is the finding of both committees that:

- SP Resolution No. 201-2005 has given authority to City Mayor Jose B. Catindig, Jr. to implement the development of a government center on Lot 268-A1 purchased from one Felizardo Graza.
- The land of the City Government of Santa Rosa and to which the Santa Rosa Science and Technology High School is situated is covered by Lots 313, 314 and 322, to which the SP has yet to declare as site for the development of a government center.
- There is no law, ordinance or resolution of any nature, designating a specific site as location for the Santa Rosa Science and Technology High School.

WHEREAS, as property of the City Government of Santa Rosa, it shall have discretion over the use and purpose of Lots 268-A1, 313, 314 and 322;

WHEREAS, Resolution 125-2006 shall be a corroboration of Resolution 201-2005 and at the same time a designation of Lots 313, 314 and 322 as additional sites for a Government Center Complex;

WHEREAS, it is in the best interest of all concerned, most especially the City of Santa Rosa and its constituents, that a site for a Government Center Complex be designated;

WHEREAS, provided there being no unambiguous law, resolution, ordinance or any explicit accord or concurrence that shall have any direct consequence on both the findings of the Committee on Laws and Government and the Committee on Education, and this Resolution;

THEREFORE, by virtue of the motion of the Committee on Laws and Government:

RESOLVED, therefore, as it is hereby resolved that the SP adopt Resolution 125-2006.
