A RESOLUTION AMENDING RESOLUTION NO. 39-2002 BY AUTHORIZING THE HONORABLE MAYOR JOSE B. CATINDIG, JR. TO REPRESENT THE CITY GOVERNMENT OF SANTA ROSA, LAGUNA TO ACT AS THE ORIGINATOR OF THE COMMUNITY MORTGAGE PROGRAM (CMP) LOAN APPLICATION FOR ALL URBAN POOR GROUPS/COMMUNITY HOUSING ASSOCIATION/HOUSING COOPERATIVES OF THIS CITY.

WHEREAS, through a Resolution No. 39, dated 6 February 2002, the then Sangguniang Pambayan authorized former Mayor Leon C. Arcillas to represent the then Municipal Government to act as the originator of the Community Mortgage Program Loan Application for all urban poor groups/community housing association and housing cooperatives in the then Municipality of Santa Rosa, Laguna;

WHEREAS, it is only legal and proper that the now City Mayor, Hon. Jose B. Catindig, Jr. be authorized to sign in all documents pertaining to the CMP Applications in the City and under the same provisions as embodied in the approved Sangguniang Bayan Resolution No. 39-2002, except paragraph 2, providing for assigning the Department of Interior and Local Government to take charge of implementing this act;
