A RESOLUTION AUTHORIZING THE CITY MAYOR TO NEGOTIATE AND ENTER INTO A CONTRACT FOR THE SALE OF THE ENTIRE 6.75 HECTARES PROPERTY OF THE CITY GOVERNMENT KNOWN AS "ANG BAGONG SANTA ROSA VILLAGE II" INCLUDING ALL IMPROVEMENTS THEREON TO INTERESTED BUYERS SUBJECT TO THE TERMS AND CONDITIONS MOST BENEFICIAL TO THE CITY OF SANTA ROSA IN COMPLIANCE WITH ALL THE LAWS, RULES AND REGULATIONS GOVERNING THE SALE OF PUBLIC PROPERTY SUBJECT TO SUBSEQUENT RATIFICATION OF ANY AND ALL PROVISIONS OF THE CONTRACT BY THE SANGGUNIANG PANLUNGSOD.

WHEREAS, the City of Santa Rosa has acquired a 6.0 hectares property located at Brgy. Tagapo for its Socialized Housing Program known as "Ang Bagong Santa Rosa Village II";

WHEREAS, since the inception of the project in 2002, the same has remained idle and unprofitable as stated in the report of the Joint Committee on Laws and Government and Committee on Housing and Urban Development and with the city government shouldering the amortization of the loan availed for the purpose, it is in the best interest of the City Council to approve this resolution so as to alleviate the City Government from the burden and in order that the money spent on the project may be put to better use for the genuine benefit of the constituents;

NOW THEREFORE, on a motion unanimously approved:

IT IS HEREBY RESOLVED, as it is hereby RESOLVED to authorize the City Mayor to negotiate and enter into a contract for the sale of the entire 6.75 hectares property of the City Government known as "Ang Bagong Santa Rosa Village II" including all the improvements thereon to interested buyers subject to the terms and conditions most beneficial to the City of Santa Rosa in compliance with all the laws, rules and regulations governing the sale of public property subject to subsequent ratification of any and all provisions of the contract by the Sangguniang Panlungsod.
