A RESOLUTION AUTHORIZING HON. CITY MAYOR ARLENE ARCILLAS-NAZARENO TO NEGOTIATE AND TRANSACT BUSINESS AND SIGN ANY AND ALL DOCUMENTS BY & BETWEEN ANY GOVERNMENT BANK FOR THE POSSIBLE EXTENSION OF LOAN IN THE AMOUNT OF Php 150,000,000.00 (P150 Million) TO FINANCE THE PROJECT – *COMPLETION AND FINISHING OF THE NEW CITY HALL BUILDING*.

WHEREAS, the former administration had implemented a Project – Construction and Renovation of Santa Rosa Science and Technology Building to be the New City Hall Building of the City Government of Santa Rosa, Laguna (Phase I and II of the Project);
