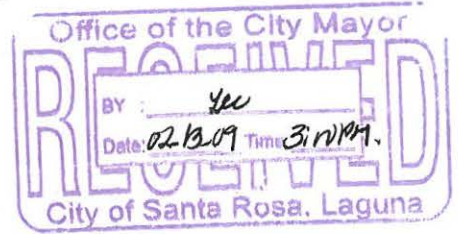

RESOLVED, therefore, as it is hereby resolved that the Sangguniang Panlungsod adopt Resolution No. 29-2009.


